REFUND POLICY

AHIT is committed to student satisfaction. If you are unsatisfied for any reason, AHIT will refund the purchase price of any course if the refund request is submitted within thirty (30) days of purchase, prior to course expiration, the course is not more than 50% completed, and the live class hasn't started, minus \$150 cost of materials and books. No refunds will be issued if online training is more than 50% complete or if live classes have started.

If one or more items in your order has an extended ship date or your class has started, your loan payment(s), including interest, may be due before the merchant ships all of the items. Please note that you may not receive a rebate of any interest that may have already accrued on an amount that later gets refunded.

EXTENUATING CIRCUMSTANCES

EXPIRATION AND EXTENSIONS

Online courses: Online courses must be completed within twelve (12) months of enrollment

date. If you are unable to complete your course within the initial twelve (12)-month period, you may extend your course access, for a fee, for up to eighteen (18) months total, when allowed by the regulatory body.* The cost of extension is twenty percent (20%) of the current retail price of the course for each thirty (30)-day extension or partial thirty (30)-day extension, in the event that the course expires prior to the end of the final thirty (30)-day extension. Access to the course after thirty (30) days from initial expiration requires re-enrollment at a discounted fee of fifty percent (50%) of the current retail cost and no progress will be kept. * The Louisiana AHIT course must be completed within 6 months of purchase date. No extensions are allowed.

Live classes and field training: Live classes and field training expire according to the class dates and attendance is required. Missing any scheduled days will result in forfeiture of tuition and require re-enrollment in an upcoming class at a discounted fee of fifty percent (50%) of the current retail cost.

Within five (5) business days of the date of purchase, you may reschedule live class dates at no additional cost, if it is more than fifteen (15) business days prior to the start of class. You may request a one-time reschedule of your selected class dates for a fee of fifteen percent (15%) of the current retail cost, paid in full at the time the request is made. All rescheduling requests must be received at least fifteen (15) business days prior to the start date of scheduled class. Rescheduling requests less than fifteen (15) business days of the start date result in forfeiture of tuition and you can be re-enrolled in a new upcoming class at a discounted fee of fifty percent (50%) of the current retail cost.

All course work must be complete prior to starting the Practicum fifteen (15) business days prior to your live training start date. AHIT and The CE Shop reserve the right to reschedule you to a future class if you have not completed your Professional Home Inspection Online Courses and will waive the reschedule fee one (1) time. Any additional class rescheduling required will be priced at fifteen percent (15%) of the current retail price of the class.

CHANGES MADE BY THE SCHOOL

If the school cancels a live class (for any reason), then you may transfer into another session of your choice at no expense. If the school is unable to make alternative arrangements that are satisfactory, then the school will refund all monies paid. TEXAS INSPECTOR FINAL EXAMS

All course final exams cannot be completed until all regular coursework is complete. There is a maximum of 2 attempts allowed. If the first exam attempt is failed, a subsequent examination must be complete no later than the 90th day after the date the original class concludes. If a student fails the second attempt, the student must re-enroll and retake the course.
